Dear parents,

On behalf of St. Brendan's and the Ministry of Evangelization and Catechesis, we welcome you to our Home Faith program!

Each of us is called to be a disciple—to say yes to Jesus' invitation and go wherever he leads us. When we surrender ourselves to the Lord and actively grow in our relationship with him, we discover true purpose for our lives along with the freedom, peace, and fulfillment that we long for so deeply. This call extends to our children and those around us, to whom we play a pivotal role in leading toward Christ and the Catholic Church that he founded. All of us want the very best for our children. We want them to know their worth in the eyes of God, to make good choices, to live out the truth, and to be authentically happy both now and forever. St. Brendan offers a number of worthwhile opportunities for adults that take less time per week than watching a movie—these programs include Walking with Purpose, Adult Bible Studies, That Man is You, and weekly Eucharistic Adoration.
- 3) To serve others in our parish community through offering your time, talent and treasure. The mission of St. Brendan is one we all share together—when each of us contribute to this mission, everyone benefits and our parish thrives!

## **Home Faith Information**

Raising your children in the Catholic faith is both a privilege and a commitment that you made when you brought your child to the waters of Baptism. Our parish community supports parents in their vocation as the primary educators through providing faith formation programs. Together, our goal is to offer a faith-engaging experience wherein children can grow in their relationship with God and learn about our Catholic Faith in an age-appropriate and organized manner.

The Home Faith program (for grades 1-8) is designed for parents to use at home in place of the Monday/Sunday evening sessions held throughout the school year. If you are interested in the option of teaching your children from home, the Office of Evangelization and Catechesis will happily provide you with the resources needed for your child's faith formation.

Home Faith can offer a rewarding opportunity for both parents and children to grow in their Catholic Faith together and focus their family life on what matters most. The lessons in the books are only the tip of the iceberg. When used effectively, Home Faith fosters a

Christ-centered culture at home that inspires daily conversations and faith devotions within the family.

### **Program Cost:**

**St. Brendan is pleased to offer reduced (parish subsidized) Faith Formation fees to active parishioners.** By Diocesan Guidelines, in order for a family to receive the parishioner rate, they must be acknowledged by the parish as a “participating member”. For this to be the case it is necessary that they:

- Are registered in the parish,
- Are recognized by the pastor as a family participating in the sacramental life of the parish by attending mass on Sundays and Holy Days,
- Contribute time and talent to the ministries of the parish,
- They regularly contribute an appropriate portion of their annual income to the financial support of the parish.
- Parishioners who do not meet this criteria will be charged the same cost as non-parishioners (see below).

### **Fees for Grades 1-8: Early Registration is July 1-21. Regular Registration is July 22-August 4.**

Home Faith follows the course of the catechetical year, beginning in mid September and ending in May. Please see the fees below. Additional Sacramental fees apply for 2<sup>nd</sup> & 8<sup>th</sup> Grade.

- **Payment for families with children ONLY in 1-5:** Select the Grade 1-5 Family Registration button which will cover the cost for however many children you have in grades 1-5.
- **Payment for families with children in 1-5 & 6-8:** Select the Grade 1-5 Family Registration button which will cover the cost for however many children you have in grades 1-5. For teens in grades 6-8, you won't pay the family fee again, but will select the proper grade books you need to purchase.
- **Payment for families with teens ONLY in 6-8:** Select the Grade 6-8 Family Registration button & then select the proper grade books you need to purchase.

\*\* If students are missing any books needed from the previous year, additional fees will apply.

### **6<sup>th</sup> & 7<sup>th</sup> Grade Student Requirements: Dates to be determined**

- Attend at least **two** Middle School Youth Ministry events
- Attend at least **one** night of the Parish Mini-Mission
- Attend at least **one** Faith Formation Mass during the school year
- Take Mid-Term in parish office

### **8<sup>th</sup> Grade Confirmation Requirements**

8<sup>th</sup> grade is a pivotal year as students ready themselves for Confirmation and prepare for high school. This is why 8<sup>th</sup> grade students are asked to meet certain requirements before they can be confirmed. These requirements are intended to help students deepen their faith

and grow in their relationship with Christ. Each 8<sup>th</sup> grade student in Faith Formation Classes, Home Faith, and the School commits to the following:

- **Attending the 8<sup>th</sup> Grade Fall Confirmation Retreat:** 2 night retreat hosted at *Damascus Catholic Mission Campus*, CYSC's brand new high-adventure camp. Past retreats have been a huge success that made a positive impact on the rest of the year. This year, the retreat will take place on Friday, 9/28 - Sunday, 9/30. More details to come in August.
- **Completing 13 service hours** during 8<sup>th</sup> grade year (hours may begin to be applied at the beginning of the summer after 7<sup>th</sup> grade). Service hours need to be completed by April 1<sup>st</sup>. It is best for service hours to be completed through a ministry or event at St. Brendan Church. Our office will periodically send out volunteer requests throughout the year. If needed, students may also complete their service hours through other types of service activities within the community as long as they are not paid to do it and the service falls in line with the Catholic Faith. Service Hours will need to be recorded on a Log Sheet available at: <https://stbrendans.net/confirmation-1>
- Attend at least **two** Middle School Youth Ministry events (*Dates TBD*)
- Attend at least **one** Faith Formation Mass during the school year (*Dates TBD*)
- Take Mid-Term in parish office
- **For parents**, *there is a required Confirmation parent meeting in the fall.* Dates and details will be sent out closer to the beginning of classes.

### **Sunday morning Children's Liturgy of the Word (ages 4-7)**

- Over the course of the school year, Children's Liturgy of the Word is typically offered at the 8:45 & 10:30 AM Masses (open to ages 4 to 7 years old). For a schedule, please see: <http://stbrendans.net/childrens-liturgy-of-the-word>.
- *Children's Liturgy of the Word* is wonderful way to complement Faith Formation classes at no cost. It aims to help engage children in the Mass and teach them how to participate (note that it is not a substitute for elementary Faith Formation though). Children are not required to attend children's liturgy of the word but are very welcome to try it out. Most children love it and parents do too! Parents do not need to sign up their children for Children's Liturgy of the Word.
- *How it works:* During the first part of Mass, children are invited to go off to a separate area in the church where they will hear about the Mass readings and receive a lively teaching that is geared toward them. Then, when the Liturgy of the Eucharist begins (during the offertory), children will re-join their families.

# Home Faith Policies & Requirements

## HOME FAITH REQUIREMENTS

While one of the advantages of Home Faith is its flexibility and family-friendly format, a high level of commitment and discipline is needed to do Home Faith effectively. *Parents will need to discern if Home Faith is a good fit for their family and if they will be able meet the basic requirements.*

**Each family enrolled in Home Faith commits to fulfilling basic requirements** that cultivate a fruitful partnership with the parish and help promote children's intellectual, moral, and spiritual development:

1. **Attending all Home Faith meetings and events throughout the year.**
2. **Using the lesson plans to teach your child the faith from home each week.**
3. **Ensuring that each child completes all homework and assignments**, including two mandatory online semester reviews for grades 1-8. Children in 7 & 8 grade must also complete weekly online assignments. Student scores are expected to exhibit progress in learning and an appropriate understanding of the material.
4. **Striving to become an authentic witness of the Catholic Faith by living and communicating all of the teachings of the Jesus Christ and the Catholic Church.** As the primary catechists, parents are expected to faithfully present the Catholic Church's teachings on both faith and morals to the best of their ability. As tough questions arise, the Office of Evangelization and Catechesis offers teaching support and welcomes theological or moral questions. Please feel free to contact us anytime.

The completion of the requirements advances families through the Home Faith program and provides an indication of commitment to the Home Faith program. As such, **all requirements must be fulfilled in order to progress to the next grade level and/or to be eligible for future enrollment in Home Faith.**

Assignments, review scores, and absences will be recorded during the year. Then, at the end of the year, the fulfillment of these requirements will be assessed for each family. If you do not hear back from our office by the middle of June, it means you have fulfilled your requirements. Families who have missed requirements will be contacted by email or phone. **Unexcused absences from parent and/or children's meetings, missed assignments, and unsatisfactory review scores will affect future eligibility to enroll in the Home Faith program and/or may result in repeating the grade.**

## HOME FAITH MEETINGS & EVENTS

Meetings are designed to provide communication, teaching, training, support, and opportunities to connect with other Home Faith families (*meetings are for parents only unless*

*otherwise noted*). Most Home Faith meetings take place on Sunday evenings. When parents and/or children arrive at each meeting/event, they will need to sign in first.

## **HOME FAITH ABSENCES**

At least one parent is expected to attend the parent meetings. If a parent or child has a legitimate excuse for missing a Home Faith meeting or event, please notify the office of the Ministry of Evangelization and Catechesis as soon as possible so we can mark down the absence as excused.

**Excused absences include:** family emergencies, illnesses, mandatory school functions, mandatory job conflicts, family reunions, weddings, funerals, and Sacramental events. Since we only have a few Home Faith meetings and events per year, it is especially important that these events be treated as a high priority. For this reason, extracurricular activities such as children's sporting events will not be able to be counted as excused absences. It's the parent's responsibility to plan and schedule accordingly in order to attend home faith events. If you have questions about absences, please contact our office.

## **Attendance Records**

Each parent (or child) will need to sign in at each Home Faith meeting or event so that you are not marked as absent. This includes both parent events and events for children/teens.

## **PARENTAL INVOLVEMENT**

Home Faith is much more than weekly lessons—it is meant to be lived by word and example every day of the week. Here is a self-assessment guide to help encourage your child's spiritual growth and bring their lessons to life:

- ✓ I become familiar with my child's book and engage him/her in conversation on the basic concepts taught each week
- ✓ I ask my child to tell me 2-3 things they' learned from their lesson
- ✓ I try to apply what was learned in their lesson to our day-to-day family living
- ✓ Someone that I love taught me my prayers when I was young; I do the same with my child
- ✓ I often use real-life situations and media to support their faith formation
- ✓ Our family has been blessed in so many ways; I am teaching my child how to give back through service



- ✓ I model an active and vibrant faith to my children by praying daily, attending weekly Mass, and participating in other parish activities like adult Faith Formation opportunities.

## Home Faith Reviews and Assignments

Children are welcome and encouraged to interact with their peers in the Home Faith program and learn together insofar as possible. This helps to cultivate a fun and engaging learning environment.

At the same time, student's assignments and reviews should reflect their own knowledge. Just as plagiarizing from the internet or copying answers from peers is not permitted in schools, cheating is also not permitted in Home Faith and will result in zero credit for the assignment or review. The amount of parental assistance given should depend on the age of the child (for example, younger children tend to require more assistance from parents with tasks like reading, typing, and understanding questions).

### Semester Reviews For Grades 1-8

Students in Grades 1-8 are required to fill out Semester Reviews that will be posted online at the end of each semester. Students will typically have two weeks to complete the reviews. Each review will consist of a series of questions based on the lessons. We will notify you by email when these reviews will be available. The purpose of these reviews is to help motivate learning and assess student progress. Younger children will likely need parents to assist them in taking the review. Each family is responsible for completing the reviews on time (siblings in the same grade will need to fill out separate reviews). Students who do not submit the reviews by the deadline may be subject to makeup work or repeating the grade over again.

### 7<sup>th</sup> & 8<sup>th</sup> Grade Weekly Assignments

Each week there will be a short electronic assignment that 7<sup>th</sup> and 8<sup>th</sup> grade students will need to complete. An email blast will be sent out with a link to the video lessons and the assignment. **Assignments must be turned in by or before the deadline.** Each student must submit his or her own work (one assignment per student). If a serious situation prevents a student from completing the weekly assignment by the deadline, please contact Josh Kilmer at [jkilmer@stbrendans.net](mailto:jkilmer@stbrendans.net) there will be a three-strike policy: if three deadlines are missed without a serious excuse, students will have to repeat the grade.

## Photo Permissions

From time to time, we will take photos at parish and Home Faith events. We sometimes share these photos on the St. Brendan website, press releases, or in marketing materials. We do not include student names with the photos.

If you prefer that your child does not appear in any photos, please let the Faith Formation office know. We maintain a database of parents who do not grant permission for photos.

## **SACRAMENTAL PROGRAMS**

The Office of Evangelization & Catechesis provides formation for the reception of FIRST EUCHARIST, FIRST RECONCILIATION AND CONFIRMATION for all children in the parish enrolled in St. Brendan School and in our Faith Formation program. Our office is charged with the preparation of specific sacraments for our parish children and it is a “charge” we take seriously. The children from St. Brendan School and the children from Faith Formation receive these sacraments together at scheduled liturgies. Our parish children are our parish children regardless of where they receive preparation. Because we are a large parish, we have more than one date or time scheduled for the reception of First Eucharist and Confirmation. Parents choose the time that best suits their needs.

Sacraments are not received in a vacuum. They are celebrated within a vibrant parish community as well as anticipated and valued within family life. Because catechesis and an understanding of each sacrament is essential, children who ask for the reception of these sacraments with no prior catechesis will need the following support before the child is eligible for that sacrament. The guidelines are listed below:

### **THE SACRAMENT OF FIRST EUCHARIST**

We are invited to participate in the celebration of the Eucharist every day of our lives, and do so, especially on weekends. Holy Eucharist is a lifelong, ongoing sacrament. By going to Mass each Sunday, you are actively supporting what your child is learning through Faith Formation and helping them learn by example that nothing is more important than our relationship with God! The reception of this sacrament is the most frequent and common public experience in a church community.

What can I teach my child and how can I prepare at HOME?

Children watch us and often imitate what we do without knowing why we do what we do the way that we do it!! Just as you teach your children HOW to answer the phone, write a “Thank You” note, or complete chores around the house, so must you explain and model for them the gestures and practices we use when receiving the Sacred Body and Blood of Jesus in the Eucharist. As the primary influence in your child’s life, you have the perfect opportunity to do this, but it takes time and a commitment on your part to do it. Ultimately, there is no better way for your child to grow in their appreciation for the Eucharist and prepare for it than by fulfilling your family’s responsibility of going to Mass each Sunday. Just like eating healthy, children may not always want to go to Mass but they need to in order to grow and thrive spiritually! Going to Mass every week can be challenging and children may be resistant, but keep going—your perseverance will pay off over time!

Who is Eligible to Receive?

- Usually received in Grade 2, but can be received at any time after that grade once preparation has been completed.
- **Children must be baptized before receiving First Communion and First Reconciliation.** If your child is not baptized they will need to go through special classes. For more information, please contact our office.
- If the child is enrolled in St. Brendan School in Grade 2, because our Catholic heritage is taught within the classroom on a regular basis, the child is eligible for the reception of First Eucharist in May of that year. If a child enters St. Brendan School in a grade other than Grade 2 and wishes to be prepared for and receive First Eucharist, the parent needs to contact our MEC office so that a plan of preparation and materials for the sacrament can be received and discussed.
- If the child enters our Home Faith Program or our Faith Formation program in Grade 2 where preparation for and catechesis on the sacrament is built into the curriculum for that year, the child will receive First Eucharist the following May once make up work for the year of catechesis that the child missed has been completed. If the child has missed 1<sup>st</sup> grade they will need to complete makeup work.
- If the child enters our program in a grade other than Grade 2, at least two years of catechesis is required before the child is eligible to receive. He/she will also need to complete “make up” work for the years of catechesis missing, and will receive specific information from our MEC office about the sacrament for understanding and review. It is the parent’s responsibility to contact our MEC office, to mentor and prepare the child.
- Any child who has special needs and has the desire to receive First Holy Communion is exempt from the preparation process as noted above and will be eligible for the reception of the sacrament following parent request.

***Attendance at the parent First Reconciliation/First Eucharist meeting in the Fall is a requirement.***

### **THE SACRAMENT OF FIRST RECONCILIATION**

The Sacrament of Reconciliation is one of God’s greatest gifts to us. Desiring to forgive us, heal us, and restore us, Jesus established the Sacrament of Reconciliation so we could receive from his boundless mercy. Preparing children to receive this gift is an awesome responsibility. It is an opportunity to lead our children to open their hearts to receive the gift of forgiveness with joy and excitement. Like receiving the Eucharist, there is no better way for your child to grow in their appreciation for the Sacrament of Reconciliation than to model it by going yourself (feel free to bring them with you and have them sit in the church while you go). They will learn from your courage as you go to Confession and your joy after you’ve finished!

- If the child is enrolled in St. Brendan School in Grade 2, because our Catholic heritage is taught within the classroom on a regular basis, the child is eligible for the reception of First Reconciliation in November of that year. If a child enters St. Brendan School in a grade other than Grade 2 and wishes to be prepared for and receive First Reconciliation, the parent needs to contact our MEC office so that a plan of preparation and materials for the sacrament can be discussed.

- If the child enters our Home Faith Program or our Faith Formation program in Grade 2 where preparation for and catechesis on the sacrament is built into the curriculum for that year, the child will receive First Reconciliation in November of that year. If the child has missed 1<sup>st</sup> grade they will need to complete makeup work.
- If the child enters our program in a grade other than Grade 2, at least two years of catechesis is required before the child is eligible to receive. He/she will also need to complete "make up" work for the years of catechesis missing, and will receive specific information from our MEC office about the sacrament for understanding and review. It is the parent responsibility to contact our MEC office, to mentor and prepare the child for the reception of the sacrament.
- Any child who has special needs, mental or physical, and has the desire to receive First Reconciliation, although not necessary, is exempt from the preparation process as noted above and will be eligible for the reception of the sacrament following parent request.

Once again, ***attendance at the parent First Reconciliation/First Eucharist meeting in the Fall is a requirement.***

### **THE SACRAMENT OF CONFIRMATION**

It is a general practice that the Bishop of each diocese decides the appropriate age when the Sacrament of Confirmation is conferred. In our diocese, it is in 8<sup>th</sup> grade when a young Catholic teen is confirmed in his/her faith.

Like First Communion and First Reconciliation, children must be baptized before receiving the Sacrament of Confirmation. If your child is not baptized they will need to go through special classes that are separate from Home Faith. For more information, please contact our office.

Information about the sacrament and its 2 year preparation cycle is outlined on our web site under the title "Sacrament of Confirmation." ***Attendance at the parent Confirmation meeting in the Fall is a requirement.***

## COLUMBUS DIOCESE HARASSMENT POLICY

### HARASSMENT POLICY

1. Harassment can take many forms. Harassment can occur at any parish activity, and/or can take place in classrooms, halls, cafeterias, gymnasiums, or even at programs sponsored by the parish at other locations. It does not include compliments of a socially acceptable nature. Harassment is verbal or physical conduct that embarrasses, denigrates, or shows hostility toward a person because of his/her race, color, religion, gender, sex, national origin, age or disability or other protected characteristics.
2. It is the policy of the Diocese of Columbus to maintain a spiritually enriching environment, in all programs and activities, free of all forms of harassment and intimidation. No participant, volunteer adult leader, or parish staff member - male or female - should be subject to unlawful harassment in any form, and specifically not to unsolicited and/or unwelcome sexual overtures or conduct, either verbal or physical.
3. Conduct which constitutes sexual harassment is prohibited. Sexually harassing conduct includes, but is not limited to, the following:
  - > Offensive sexual flirtations, advances, propositions;
  - > Continued or repeated verbal abuse of a sexual or gender-based nature;
  - > Explicit or degrading sexual or gender-based comments about another individual or his or her appearance;
  - > The display or circulation of sexually explicit or suggestive writing, pictures or objects;
  - > Any offensive or physical conduct which shows hostility or aversion toward an individual because of gender or sex;
  - > Graffiti of a sexual nature;
  - > Fondling oneself sexually or talking about one's sexual activity in front of others;
  - > Spreading rumors about or categorizing others as to sexual activity.

Sex harassment is not limited to conduct that is sexual in nature - it also includes harassment that is based on **gender**. Gender-based harassment, which is also prohibited, is conduct that would not occur except for the sex of the person involved. An example would be referring to a woman by or as a female body part, or a demeaning sex-based term, or treating people differently because of their gender. The same prohibitions apply with regard to inflammatory or offensive comments or conduct which are based upon race, color, age, religion, disability, or national origin. In short, working relationships between employees and volunteers must be based on mutual respect.

Sexual harassment also includes the taking of, or refusal to take, any personnel or other action on the basis of a person's submission to or refusal of sexual overtures. No person should so much as imply that an individual's "cooperation" or submission to unwelcome sexual activity will have any effect on the individual's employment, assignment, compensation, advancement, development, program evaluation, participation in parish programs or activities, or any other condition of employment or achievement.

Not all physical conduct is necessarily considered sexual in nature. (For example, a catechetical leader hugging a child after an accomplishment, a catechist consoling an adolescent with an injury, or physical conduct during an activity to enhance catechetical learning like engaging in movement to accompany liturgical music would not be considered sexual conduct.) However, peer-based sexual harassment is a form of prohibited conduct where the harassing conduct creates a hostile environment.

4. A sexually hostile environment can be created by a parish employee, volunteer, participant, or visitor to the parish activity.
5. Any person who believes that he/she is subject to unlawful harassment or intimidation must contact either the (a) program administrator, (b) pastor, or (c) diocesan director of religious education. A complaint must be filed in writing. In the event that an individual alleges harassment by a program administrator or a pastor, the individual may file the complaint with the diocesan director of religious education. All complaints will be promptly investigated, and the person initiating the complaint will be advised of the outcome of the investigation.
6. Where it is determined that harassment has occurred, the appropriate authority will take immediate disciplinary action against any program administrator, volunteer, or staff engaging in harassment. The response shall take into account the individuals and circumstances. Such action may include, depending on the circumstances, disciplinary measures up to and including termination of services.
7. No retaliation against anyone who reports harassment will be tolerated. The Diocese prohibits such retaliation and will take appropriate responsive action if retaliation occurs.
